- THE CLUB HAS AN AUTHORISED SAFETY OFFICER WHO MAY ASK TO SEE YOUR SAFETY EQUIPMENT. SHOULD YOU NOT HAVE THE COMPULSORY SAFETY EQUIPMENT THEN YOU AND YOUR CREW WILL BE DISQUALIFIED FROM THE EVENT UNTIL SUCH TIME AS THE SAFETY BREACHES ARE RECTIFIED.
- ALL FISH CAUGHT BY THE CAPTAIN AND CREW PRIOR TO AND DURING DISQUALIFICATION WILL BE INELIGIBLE FOR THE CONVENTION.
- IT IS THE RESPONSIBILITY OF THE CAPTAIN TO PRESENT HIS BOAT FOR RE-INSPECTION. IF THERE IS A CHANGE OF CAPTAIN, THEN THE NEW CAPTAIN SHALL ALSO COMPLETE A SAFETY VERIFICATION FORM.
- IT IS ACKNOWLEDGED THAT NEITHER THE ANSA VICTORIAN BRANCH NOR THE CLUB HOSTING THIS CONVENTION WILL BE HELD RESPONSIBLE FOR ANY ACCIDENT OR INCIDENT WHICH MAY OCCUR DURING THE RUNNING OF THE CONVENTION AND THAT COMPETITORS ENTER ENTIRELY AT THEIR OWN RISK.
